### Guidelines for Group Registration for Shri Amarnathji Yatra 2026

1. The facility of group registration has been made available for Yatris intending to undertake the Yatra in a group of 5 or more members. The individual members of the Group can apply together by registered post to the Chief Executive Officer, Shri Amarnathji Shrine Board, 2<sup>nd</sup> Floor, Block-III, Engineering Complex, Raj Bagh, Srinagar- 190008 to secure registration for Yatra 2026.
2. The Group Registration shall commence from 14<sup>th</sup> April, 2026 and conclude on 31<sup>st</sup> May 2026.
3. The last day for receipt of Application Form for Group Registration by post is 20<sup>th</sup> May, 2026.
4. Group Registration shall be done on first-come-first-serve basis, subject to the date-wise and route-wise availability of slots, subject to maximum 30 registrations per group per day per route.
5. To apply for the Yatra permit under Group Registration Facility, the Group Leader (one of the intending pilgrims of the group) shall have to send the following documents in respect of each member of the Group by registered post at the address indicated above:
  - a) Filled in Application Forms.
  - b) Original copies of the prescribed Compulsory Health Certificates (CHCs) issued by the Authorized Doctor/ Medical Institutions.
  - c) One passport sized photograph of each applicant, which is to be signed by the concerned on the front side of the photograph.
  - d) Yatra Registration Fee @ ₹250 per Yatri.
  - e) Mailing address of the Group Leader, along with mobile number, and e-mail ID.
  - f) Postal Charges as mentioned below:

6. The formats of the Application Form and CHC and the list of Doctors/ Institutes authorized to issue the CHC are available at Shri Amarnathji Shrine Board's website: [www.jksasb.nic.in](http://www.jksasb.nic.in).
7. The amount payable to the Shrine Board (Yatra Registration Fee and Postal Charges) shall be sent as Bank Draft drawn in favour of Chief Accounts Officer, Shri Amarnathji Shrine Board.
8. No Yatri who is below the age of 13 years or above the age of 70 years and pregnant lady with six weeks pregnancy would be registered to undertake Yatra, even if Compulsory Health Certificate (CHC) has been issued by authorised Doctors.
9. In case, requisite registration slots are not available on a given date for which Registration has been sought by the Group, the Group Leader shall be contacted over telephone and informed about the next available slot.
10. For Yatra 2026, CHCs issued only on or after 8<sup>th</sup> April, 2026 would be valid for registration.
11. The registered yatri through group registration facility shall have to collect RFID card after biometric eKYC authentication at any one of the centers established at various locations in Jammu & Kashmir Divisions. No yatri shall be allowed to cross access control gate at Domail / Chandanwari without a valid RFID card. Further, yatri shall be allowed to embark on her/ his Yatra only on the day and route for which she/ he has been registered.
12. Shri Amarnathji Shrine Board shall not be responsible for any postal delay.
